From Susan Blackburn, Chief Executive

In this season of gratitude, I want to thank you for your philanthropic support which has strengthened our local healthcare system's response to the pandemic. As COVID-19 entered the United States, Providence St. Mary Medical Center responded right away.

Since the outbreak, our needs for equipment, supplies, personal protective equipment and so much more have been overwhelming and continuous. The community's generosity and support is humbling and has allowed Providence St. Mary to rise up to meet unprecedented community needs.

In March, we worked with the Foundation to prepare the Southgate campus as a temporary hospital for additional beds (thankfully, the additional beds have not been needed thus far).

Our Population Health Team partnered with the Health Department to provide local contact tracing and support to COVID positive patients through daily phone calls, grocery delivery and mental health support.

This work continues as does our ongoing support of patients receiving care in the medical center as well as throughout the community. Our dedicated healthcare heroes rise to the challenges of the pandemic every day while caring for each of our patients' physical and emotional needs, often staying by their side when their families can't be with them due to COVID restrictions.

We are thankful to partner with the Foundation to address the needs of community members outside of our hospital walls by utilizing the Good Samaritan Fund to buy shoes for a barefoot patient, pay for transportation to and from doctor visits and so much more. The Good Samaritan Fund has helped twice the number of patients this year than in 2019 - a true testament to the growing need right here in our community.

In early November, we signed a contract with Walla Walla County to provide COVID quarantine housing at the Southgate campus. Public Health provides screening of potential residents who can't quarantine on their own but aren't sick enough to require hospitalization. The design of the Southgate building allows for the safe housing of these individuals without impacting other services at the facility.

This last week we've had the highest number of COVID patients we've ever cared for in our hospital. We are taking steps to increase our capacity to free up more inpatient hospital beds. While we are taking these steps, I urge you to do your part to keep these beds from being filled. The best thing you can do to support our health care workers is wear a mask, wash your hands and practice social distancing.

While we join you in facing the challenges of each day, we are optimistically looking forward and

planning for the future. We are anxious to begin vaccinating our caregivers, as well as the community we serve. Planning for the COVID-19 vaccine began several months ago and is now in full swing as we rapidly approach the receipt of our first vaccine allocation. The vaccine will be rolled out in a phased approach, following State and Federal guidance, and we look ahead to the future when we are able to rest assured that our most vulnerable are protected from this illness.

Thank you for all you are doing to make our work possible.

The Human Bean raises \$3,737 for early detection

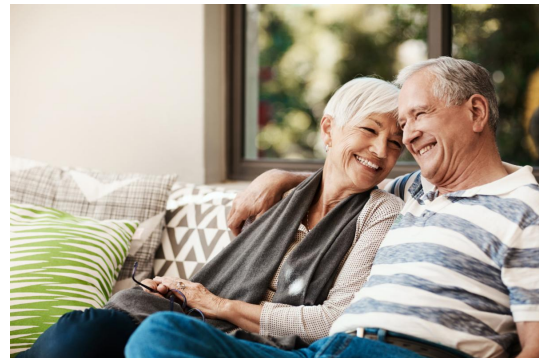
