A letter from our CEO, Celine Regalia

We are learning to live a "new normal" and provide care in new ways in the face of a pandemic. We are struggling to understand the inequities and injustices in human rights facing our nation.

Now more than ever, we must advocate for those most vulnerable in our community!

The Collabria Care vision is to "build a community in which exceptional care and support for life-limiting conditions and the transitions of aging are accepted, expected and available to all." To do this, we must acknowledge and appreciate the rich diversity within our community and continue to break down any barriers that would exclude individuals and their families from receiving care. These could include a lack of access or understanding as to what care is available; a language barrier; discrimination because of age, race, sexual orientation or gender identity; or stigma often attached to a serious illness or being COVID-19 positive.

We are also working to ensure that diversity is reflected and celebrated as part of our work environment and that all our staff, as well as those

we care for, are treated with compassion, dignity, justice, excellence, and integrity.

As we reminisce about 2019, feel the impact of 2020 and look forward to 2021, it is imperative that we embrace those we serve now and we find ways to build connection and trust with those we have yet to serve during life's most challenging transitions.

What your funding supports

1 CHARITY CARE

Available for clients who are unable to afford our services or for whom services are not covered by their insurance.

2 COMMUNITY BEREAVEMENT SUPPORT

Specialized Individual Grief Counseling, Groups, and Workshops.
Available to the community free of charge and offered in English and Spanish.

3 CAREGIVER WORKSHOPS

Assistance for those caring for someone with Alzheimer's or dementia, or Parkinson's disease.
Available to the community free of charge and offered in English and Spanish.

4 FREE CAREGIVER CONSULTATIONS

Free to anyone who needs expert guidance from a medical social work to help navigate the challenges of being a family caregiver.

Consultations include connection to resources, education about the disease process, and emotional support for the caregiver. Follow-up is done to ensure caregiver remains supported.

5 BRAIN HEALTH CLASSES & MEMORY SCREENINGS

Available to the community free of charge. Offered in English and Spanish. Provided at Collabria Care, Rianda House.

6 GAPS IN REIMBURSEMENT

Medi-Cal reimbursement for our Day Program has remained flat while costs have increased. *75% of cost is reimbursed, remaining 25% is fundraised.*

Private Pay participants are on a sliding fee scale based on income. *Remaining portion is fundraised.*

7 GRACE FUND

Pays for in-home care provided by individuals or homecare agencies for Hospice patients, up to \$3,000 per patient.

8 LASTING MEMORIES FUND

Funding to create special moments for patients and their loved ones, to add meaning to their final days.
