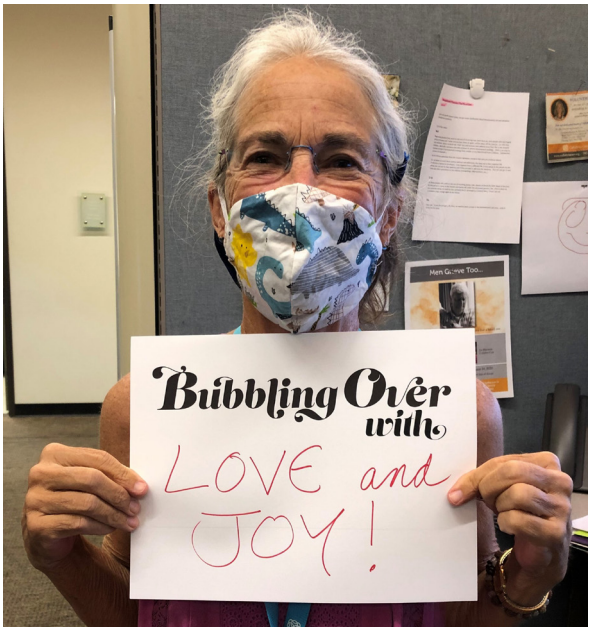
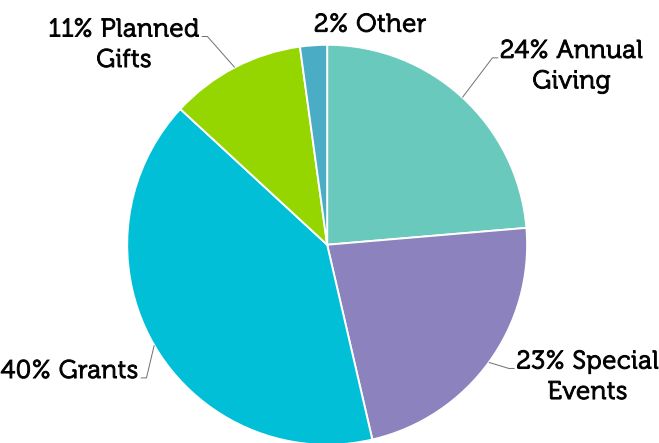

Day Program

The greatest change at Collabria Care in 2020 was made when our Day Program had to transition into a *Center Without Walls* to care for our participants in their homes due to the COVID-19 pandemic.

- Throughout the year our primary goal remained the same — **to keep our participants and their caregivers safe, healthy, and out of the hospital** thus protecting them and our critical healthcare resources. At the onset of the pandemic, our nursing and social work teams quickly transitioned to provide uninterrupted care via telemedicine to support 165 very vulnerable Seniors—many with multiple chronic conditions and Alzheimer's or dementia—and an estimated 247 caregivers.
- By the end of 2020 we were providing an average of **5 hours of daily therapeutic programming via online Zoom classes in English and Spanish**. Amazon Fire tablets were loaned out and caregivers trained to ensure that any interested participants could benefit. Our participants could be found enjoying music or art therapy, brain fitness, exercise classes, support groups, or socializing while playing Bingo!

More than 1,700 individual donor-supported activity kits were created and delivered to our Day Program participants. These kits, delivered twice a month to each participant, included everything from art and gardening projects to therapy equipment and personal care items.

Ensuring that our participants with Alzheimer's and dementia had the medical support they needed, our nurses filled special medication dispensers to ensure that dosages were correct and taken on time.



Palliative Care

- Our Palliative Care team worked diligently to strengthen partnerships and increase referrals from community healthcare providers, including Queen of the Valley Medical Center and Adventist Health St. Helena to ensure that the community had access to care. As a result, we experienced a 15% increase in the total number of Palliative Care patients served from 2019 to 2020.
- Thanks to the generous support of donors like you, we were able to add spiritual care to our multidisciplinary Palliative Care services. This new layer of support helps improve quality of life for our patients and families.
- As part of our commitment to provide the right care at the right time, we improved the coordination of care between our programs. This has helped ensure that patients can transition easily from our Day Program to Palliative Care and from Palliative Care to Hospice.



Hospice

- 539 Collabria Hospice patients and their families received the tender care they needed while not only facing the overwhelming challenges of end of life but the complexities of the pandemic, wildfires, and power outages. Our services became even more important in 2020 as **more people wanted to spend their last days at home with their loved ones rather than alone in a hospital or facility.**
- Due to the pandemic our Bereavement program quickly transitioned to offer counselling sessions and support groups online. The new format helped us care for friends and family members near and far as they grieved the loss of their loved one.
- In the summer of 2020, Collabria Care hired a new Medical Director, Dr. Paul Laband, a board-certified internist with over 27 years of experience in primary and hospital-based care. He is also an experienced hospice physician and a Certified Hospice Medical Director.

A Little Help from Her Friends:

How Our Day Program, Palliative Care, and Hospice Teams Collaborated to Care for Marilyn

Everyone's journey with Collabria Care is different. We offer a full continuum of care – from serious illness through the end of life – so we can be there for our community whenever we're needed. However, it's rare that we are honored to care for someone like Marilyn, who has been a part of our family for 13 years.

Marilyn has been no stranger to adversity. She was born with a developmental delay, lost her husband, Jerry, more than 30 years ago, and now lives with kidney failure.

These challenges have never stopped her from living a full and joyous life. But like all of us, sometimes it can be overwhelming and too much for even her to face alone.

Marilyn came to the Day Program in December of 2008. She had just retired and needed something else to keep her going. "One of the biggest issues older adults face is isolation and a sense of not belonging, which can worsen chronic health issues," says Day Program Director, Jill Wood. "Coming to the Day Program gave Marilyn purpose, a reason to get out, and she loves being around others. She enjoys the physical therapy, and even joined the weight-lifting group. These activities helped maintain her health, so she was able to continue to enjoy the things that were important to her, like going to ball games."

That was up until about a year ago, when Marilyn's kidney failure began to worsen and she needed more support managing her health. While still a participant in the Day Program, she was enrolled in our palliative care program, and then right before the pandemic began, she began receiving Collabria Hospice care.





"The transition to the right care at the right time, couldn't have been easier or better, because we already had a good relationship with her," says Jamie McNamara, Collabria Nurse Navigator. "So we were able to have gentle, yet real conversations about what quality of life means to her and how to honor that. Staying in her own home, where she's lived for 48 years, was very important to Marilyn—but would have been really difficult without support from Collabria Palliative Care, Hospice, and Day Program. Her team helped her manage her condition and coordinated all of her care. Without that, the only other option would have been a nursing home—and that would have been no quality of life for her. We do whatever we need to do to keep her at home, safe and comfortable," says Jamie.

Today, Marilyn continues to be actively involved in the Day Program through its *Center Without Walls* where she participates in the Zoom exercise classes nearly every day, cuddles up with her favorite blanket and listens to stories during reading group. Her bright personality continues to be a ray of light in the online world as she joins her Day Program friends for bingo and conversation groups too.

In June we celebrated Marilyn's 80th birthday in the Day Program! In addition to the fabulous hats, our team put together a Marilyn-themed game of Family Feud! It was a truly a joy to be together. In addition, we were also celebrating gradually bringing our Day Program participants back into our Center!

Our heartfelt thanks go out to our donors, volunteers, and all those who supported our programs through the pandemic, wildfires, and the other challenges we faced in 2020 – we are deeply grateful.

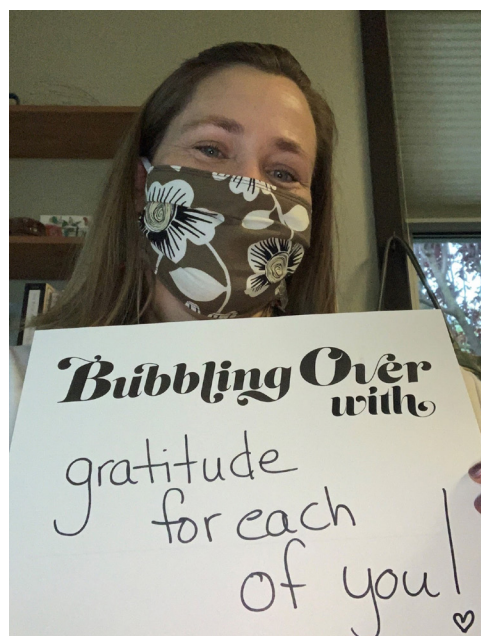
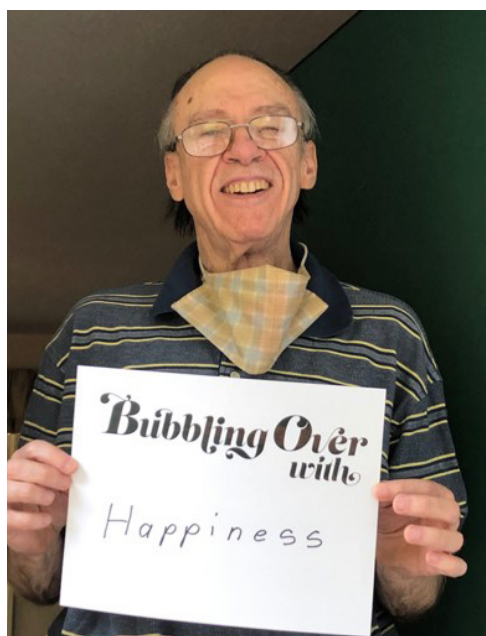

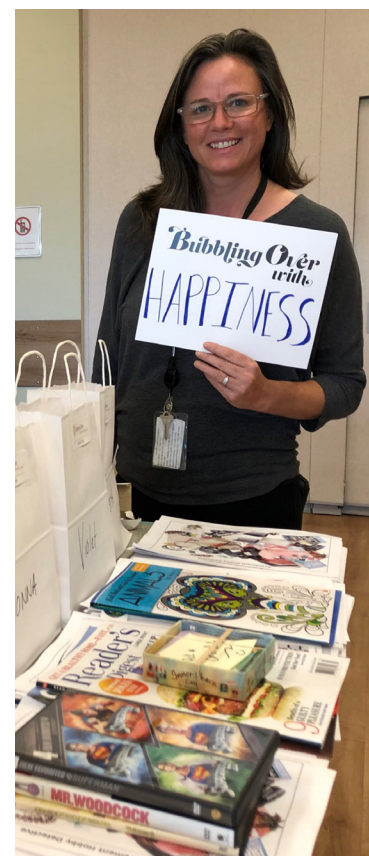
